

ORDINANCE NUMBER 570

**AN ORDINANCE AMENDING ORDINANCE 38-4-82 (C) OF THE  
VILLAGE CODE OF THE VILLAGE OF ALHAMBRA, STATE OF  
ILLINOIS**

Whereas, the Village of Alhambra deems it is in the best interest of the Village and its residents to amend **SEWER RATES** to prevent a deficit of Village funds.

**NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE  
VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF ALHAMBRA, STATE  
OF ILLINOIS, THAT THE VILLAGE CODE OF THE VILLAGE OF ALHAMBRA  
BE AMENDED AS FOLLOWS:**

**SECTION ONE**

That Ordinance #552 be amended, and the official code be, and is hereby amended, as follows:

**The following text shall be deleted in its entirety:**

**38-4-82 (C) RATES:** A minimum charge of \$18.00 per month shall be applied to all users whose water consumption does not exceed 1,000 gallons per month. Usage in excess of 1,000 gallons per month shall be charged \$3.50 per 1,000 gallons inside village and \$3.50 per 1,000 gallons outside village.

**And replaced in its entirety by the following text:**

**38-4-82 (C) RATES:** A minimum charge of \$18.00 per month shall be applied to all users whose water consumption does not exceed 1,000 gallons per month. Usage in excess of 1,000 gallons per month shall be charged \$5.50 per 1,000 gallons inside village and \$5.50 per 1,000 gallons outside village.

**SECTION TWO**

All ordinances or parts of other ordinances in conflict herewith shall be and hereby are repealed to the extent of any such conflict. Nothing in this Ordinance shall be construed to affect any suit or proceeding now pending in any court, any rights acquired, any liability incurred, any cause of action acquired or existing by reason of any ordinance or part thereof repealed by this Ordinance. No accrued legal right or remedy of any kind or character shall be lost, impaired or affected by the Ordinance.

**SECTION THREE**


That the provisions and sections of this Ordinance are separable. If any part of this Ordinance shall be held void, such part shall be deemed severable, and the invalidity thereof shall not affect the validity, force, and effect of the remaining parts of this Ordinance.

**SECTION FOUR**

This Ordinance shall be in full force and effect on and after its passage approval in accordance with State Statutes.



**AN ORDINANCE AMENDING ORDINANCE 38-3-80 OF THE VILLAGE CODE OF THE VILLAGE OF ALHAMBRA, STATE OF ILLINOIS**

Whereas, the Village of Alhambra deems it is in the best interest of the Village and its residents to amend water rates to prevent a deficit of Village funds.

**BE IT ORDAINED BY THE MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF ALHAMBRA, STATE OF ILLINOIS, THAT THE VILLAGE CODE OF THE VILLAGE OF ALHAMBRA BE AMENDED AS FOLLOWS:**

SECTION 1. That Alhambra Village Code 38-3-80 be amended as follows:

SECTION 2.

38-3-80 **WATER RATES.** The present wording of this paragraph shall be deleted and replaced by the following:

38-3-80 **WATER RATES.** There shall be established the following rates and charges for the use of the water system of the Village, based upon the amount of water consumed as follows.

(A)	<b><u>WATER RATES INSIDE VILLAGE.</u></b>	
First	1,000 gallons per month	\$18.00 MINIMUM CHARGE
Over	1,000 gallons per month	\$7.00 per 1,000 gallons
(B)	<b><u>WATER RATES OUTSIDE VILLAGE.</u></b>	
First	1,000 gallons per month	\$26.00 MINIMUM CHARGE
Over	1,000 gallons per month	\$9.00 per 1,000 gallons
(C)	<b><u>BULK SALES.</u></b>	\$11.00 PER 1,000 gallons


SECTION 3. REPEAL: That all Ordinances in conflict herewith are repealed to such conflict.

SECTION 4. SEVERABILITY: That the provisions and sections of this Ordinance are separable. If any part of this Ordinance shall be held void, such part shall be deemed severable, and the invalidity thereof shall not affect the validity, force, and effect of the remaining parts of this Ordinance.

SECTION 5. EFFECTIVE DATE: That this Ordinance shall be in full force and effect upon its passage and approval.
